REQUEST FOR EXPRESSION OF INTEREST FOR *Procurement of Consultancy Services for MRT3 Asset Valuation*

1. The *Department of Transportation-Metro Rail Transit 3 (DOTr-MRT3)* through the *2019 General Appropriations Act (Continuing Appropriations)* and *2020 General Appropriations Act*, intends to apply the sum of *Forty-Nine Million, Nine Hundred Forty-Three Thousand, Eight Hundred Seventy-Nine Pesos and 12/100 (Php49,943,879.12)* being the Approved Budget for the Contract (ABC) to payments under the contract for *Procurement of Consultancy Services for MRT3 Asset Valuation*. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The *DOTr-MRT3* now calls for the submission of eligibility documents for *the MRT3 Asset Appraisal and Valuation*. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before *01 December 2020, 10:00 AM* at *Administrative Division, MRT3 Depot, EDSA corner North Avenue, Barangay Bagong Pag-asa, Quezon City*. Applications for eligibility will be evaluated based on a non-discretionary “pass/fail” criterion.
3. Interested bidders may obtain further information from *DOTr-MRT3* and inspect the Bidding Documents at the address given below during *8:00 AM to 5:00 PM*.
4. A complete set of Bidding Documents may be acquired by interested Bidders on *23 November 2020* from the address at *MRT3 Depot, EDSA corner North Avenue, Barangay Bagong Pag-asa, Quezon City, in the amount of Twenty-Five Thousand Pesos (Php25,000.00)*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”, and its Implementing Rules and Regulations (IRR). The short list shall consist of *three (3)* prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:


Experience and qualification of the consulting firm and its Project Manager intended to be assigned for this Project. Details of the scoring system are indicated in the Eligibility Data Sheet.

6. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

7. The Procuring Entity shall evaluate bids using the *Quality-Cost Based Evaluation/Selection (QCBE/QCBS)* procedure. The Procuring Entity shall indicate the weights to be allocated for the Technical and Financial Proposals. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
8. The contract shall be completed within *six (6) months*.
9. The *DOTr-MRT3* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
